  - a. <u>Discussion on Switch to Sonoma Clean Power</u>

Superintendent Kelley reported that he enrolled the Wastewater Treatment Plant with Sonoma Clean Power. Customers opting out of SCP service 60 days or more after SCP service starts must pay an SCP termination fee of \$25 and would be subject to PG&E's terms and conditions of service, which prohibit a customer from returning to SCP service for one year. SCP termination fees are not assessed for opting out within the first 60 days.

- 6. Groundwater Management
  - a. Monthly Groundwater Management Report

October 1, 2018 was the beginning of the 2018-2019 rain year. Average annual precipitation in Mendocino was 40.23 inches and average rainfall in June was 0.50 inches. No rainfall had been measured for the month. Total annual rainfall by June was 44.71 inches. Mendocino had received 111.1% of normal annual rainfall for this water year.

A No Water Shortage condition in the District was due to above normal rainfall for this rain year.

The average DTW measurements District-wide in the 24 monitoring wells on June 14, 2019 was 13.6 ft.

The average last year at this time was 14.5 ft.

### 9. <u>District Superintendent's Report</u>

Operators performed routine repair and maintenance at the wastewater treatment plant during June 2019. Plant operators were waiting for repair parts for the automatic bar screen compactor.

Repairs were also being made to the tertiary filters backwash controls by Operator Steve Acker. The existing backwash controls were scheduled to be completely replaced with a programmable logic controller during the plant upgrade project later this year.

Mendocino Water works replaced four old backwash air valves in the pipe gallery on May 17 2019.

There were no MCCSD collection system sanitary sewer overflows to report through June 12th.

The District has transferred recycled water to the High School several times in June 2019.

The Safety Officer conducted the monthly safety inspection of the plant and safety meeting on June 13, 2019. The 30 minutes safety meeting was on Heat Stress.
